Fall State Legislative Update

The Wisconsin State Legislature is working on a variety of important hospital-related issues during its fall legislative session. The Wisconsin Hospital Association is working on the following and wanted to keep you updated.

Success! Senate Bill 137/Assembly Bill 139 (Jandre)

With the support of HEAT members, the state Assembly and state Senate passed legislation to address the Supreme Court's split decision in *Jandre v. Wisconsin Injured Patients and Families Compensation Fund*. Senate Bill 137 and Assembly Bill 139 address Jandre by requiring a physician to inform his or her patient about the availability of reasonable alternate medical modes of treatment and the risks and benefits of those treatments. The bill would establish the "reasonable physician" standard as the legal standard a physician must meet when informing his or her patient. As a result of the complex Wisconsin Supreme Court decision in Jandre, which included three separate opinions none of which garnered four votes, physicians are left with an unclear standard to meet when obtaining a patient's informed consent for medical treatment.

For those of you who are HEAT members and contacted your legislators in response to our Action Alerts on Jandre, thank you! It was successful and we should celebrate!

WHA's Behavioral Health Agenda

Since 2008, WHA has been working with the WHA Behavioral Health Task Force, chaired by Bellin Health System President/CEO George Kerwin, to develop proposals to help modernize Wisconsin's mental health policies that have created barriers to better outcomes for individuals with mental health needs in Wisconsin. WHA has worked closely with members of the legislature to advance many of these recommendations as legislation for this fall. *One of WHA's key recommendations is to pass the "HIPAA Harmonization Bill" which would enable all treating health care providers to view their patient's physical health and mental health information, except for psychotherapy records, as is permitted by the federal HIPAA health care privacy and security law.*

Wisconsin's current mental health records law, which predates the federal HIPAA laws, requires in practice that mental health information be segregated from a patient's physical health information in their medical record and forces treating health care providers to make assumptions about an individual's mental illness in the absence of accessible relevant information about the individual's mental illness in the medical record. To the detriment of patients, this segregation of information stands in the way of modern holistic and coordinated care that integrates physical and mental health. For example, a 2013 published study from the Johns Hopkins Department of Psychiatry found that hospitals that could share mental health information with non-mental health providers had approximately 35% fewer psychiatric readmissions.

WHA's other proposals include several reforms to the current emergency detention process, a clarification on a physician's duty to warn and tools that will help policy makers understand the current set of core mental health services provided by counties across the state.

WHA will be seeking passage of these bills. Please watch for HEAT alerts in the coming weeks and TAKE ACTION. Your emails do make a difference and help WHA with our advocacy in the Capitol.

The critical access hospital (CAH) designation is again being focused on. 52/53 of the 58 CAH hospitals that are in the line of fire as far as losing that designation - 61 state legislators

(bipartisan) have signed and sent a letter to Congress asking for the dismissal of this action. The closing of CAHs will negatively affect many in small rural areas. Our hospitals in Wisconsin focus on high quality care, value, and community commitment, and that equates to better results for our patients and improved health care for all consumers. We should be very proud of our hospitals and do our best to advocate for them!

The Wisconsin Hospital Association depends on hospital advocates, including our volunteers, to make their voices heard in the capitol. They take our involvement very seriously and ask that as many of us as possible join the HEAT program. Encourage others in your volunteer group to apply and let's not forget the staff at your hospital! Less than 2% of our hospital workforces are HEAT members. Let this be the day that YOU join HEAT. You will receive an alert when it is time to contact your legislators on an issue. Ask your fellow volunteers and the staff at your hospital to join, as well. Community Health Education Report

This information is from the latest correspondence I received from the Alzheimer's Association. It is estimated that every 68 seconds someone in the United States develops Alzheimer's disease.

Alzheimer's quick facts:

- 1. Deaths from Alzheimer's increased 68 percent between 2000 and 2010, while deaths from other major diseases, including the number one cause of death (heart disease), decreased.
- 2. In 2013, the direct costs of caring for those with Alzheimer's or other dementias to American society will total an estimated \$203 billion, including \$142 billion in costs to Medicare and Medicaid.
- 3. The direct cost of Alzheimer's and other dementias is greater than any other condition in the United States, including heart disease and cancer.
- 4. Alzheimer's is the only cause of death among the top 10 in America that cannot be prevented, cured, or even slowed.
- 5. Almost two-thirds of Americans with Alzheimer's 65 and over—3.2 million—are women.

Some milestones in the fight against Alzheimer's are:

- 1980 The Alzheimer's Disease and Related Disorders Association is formed.
- 1982 The Association awards its first research grant.
- 1993 FDA approves first drug treatment for Alzheimer's
- 2000 The Association assumes management of the Alzheimer's Association International conference (AAIC)—the world's largest conference of its kind.
- 2010 The Association launches *TrialMatch*, a tool to help prospective participants identify clinical studies that might be a good fit.
- 2012 The first-ever national Alzheimer's Plan is released an historic achievement. It outlines the important goal to prevent and effectively treat Alzheimer's disease by 2025.
- 2013 President Obama allocates 100 million dollars toward the fight against Alzheimer's and the implementation of the National Plan to Address Alzheimer's Disease.
