It's Supposed to be about Health REFORM!

A disturbing trend has emerged over the past couple of weeks in Washington, D.C. The health reform discussion has morphed into a debate about how much to cut provider payments so that "savings" can be spent to expand coverage for the uninsured. In

addition to large Medicare cuts, the other area of focus has been on the "public (government)

plan alternative".... whether or not there will be a Medicare-like program that will "compete" with commercial insurance. That issue is an ideological litmus test for many lawmakers and, like large Medicare cuts, is problematic for providers.

But the missing issue is....REFORM. The importance of aligning payment and delivery is an essential element of transformational reform. And transformational reform is a key principle in most state and national hospital association health reform platforms. Those statements of principle are supposed to serve as a roadmap to achieving lower costs and improved outcomes. So it's problematic that specific initiatives that actually incent this alignment are missing in action at this late stage of the national debate.

Take a close look at the Senate HELP Bill and the House Leadership Bill and what appears to be included in the Senate Finance Committee legislation. The sum total as to how transformational delivery reform is recognized and incented in these proposals is just about nil, unless you count the nebulous discussion of Accountable Care Organizations (ACOs) and "demonstration projects" that might be encouraged (but no new dollars are identified in the proposals) beginning years from now. That's just plain wrong.

Health reform must align payment with high-level performance. No less than President Obama, just two weeks ago, called for such an outcome. That's why WHA has joined a handful of other state hospital associations to support a value-based incentive approach. The concept of real reform shouldn't be MIA.

Spotlight On Federal Health Care Reform

(As of July 15, 2009) - The Wisconsin Hospital Association continues to engage with Congress on various options being discussed in Washington, DC regarding health care reform. The activity related to health care reform is so substantial it cannot be adequately covered in this article. Here are the most important items and updates:

- Currently there are three versions of health care reform legislation being developed: the U.S. Senate Finance Committee version; the U.S. Senate HELP Committee version; and the U.S. House version put together by three House Committees. Each version has similarities and differences. The goal is to have Congress vote on something by August, a *very* aggressive timeline.
- The most contentious issues in health care reform are:
 - The cost of reform and how to finance it. Estimated costs for some of the reform proposals have ranged from \$600 billion to over \$1.5 trillion! Cuts to Medicare, taxes on health care benefits among others are all options being discussed. The Obama Administration has also engaged with health care groups on their "shared responsibility" in all of this. To date, his Administration has cut several "side deals" in order to begin bridging the cost chasm. For example, the pharmaceutical industry agreed to \$80 billion in cuts and three national health care associations agreed to \$155 billion in cuts (see bullet point further down).
 - The "public plan option" (a government plan option to compete with private plans). The public plan option has engendered significant opposition for fear it will supplant private-sponsored health care plans. This fear is based on the fact it will be based on artificially low Medicare rates, which, for example in Wisconsin, do not reimburse our hospitals at even the *cost* of providing care to Medicare patients. In addition, the public plan option could provide a perverse incentive for those with employer-sponsored coverage to decline that coverage and opt-in to the public plan.
- American Hospital Association, Federation of American Hospitals, and the Catholic Health Association agree to \$155 billion in Medicare cuts over 10 years in return for staggered reductions to the Disproportionate Share Hospital payments program and assurances that the public plan option includes adequate hospital reimbursement rates. Reductions will come from lower Medicare update factors over 10 years (103 billion); reducing DSH payments, phased in during years 2015-2009 (\$50 billion); and reducing payments for avoidable hospital readmissions (\$2 billion).
- WHA submitted comments to the Wisconsin Delegation and Senate Committees on various health care reform proposals.
- WHA focuses attention on our low-cost, high-quality provision of health care; yet Medicare reimburses other states much higher. Therefore, WHA spearheads coalition among other states to introduce "value" into the reimbursement formulas as a way to incentivize for higher quality and lower cost.
- Wisconsin Delegation touts the state's low-cost, highquality health care "value" in several letters to their colleagues. Thanks to Senators Kohl and Feingold and Reps. Obey, Baldwin, Kagen, and Petri for their efforts on this.

Public Policy Education Report

It was so great to meet so many of you during Spring Tour. Your meetings and hospitality were wonderful. The message then and now is, "We are the Voice for Volunteers regarding Health Care in Wisconsin," and our voices must be heard to make a difference.

Great News! The **Smoke Legislation** was passed and signed by the Governor and is effective July 6, 2010. Thanks to everyone that contacted your legislators; many of you have been involved in

the campaign for the past 3 years - great work.

Another issue many of you worked on was changes to "Medical Record Access." The 2009-2011 Wisconsin State Budget, 2009 WI Act 28, makes changes to Wisconsin's medical record access statute, § 146.83, Wis. Stats. The Governor signed Act 28 into law on June 29, 2009. The effective date for the changes is July 1, 2009. The most significant changes to the health care access statutes include a new requirement to provide copies of patient health care records in an electronic format upon request, and a new statutory fee schedule for copies of medical records. For more information go to www.wha.org and view the July 10, 2009 issue of *The Valued Voice*.

President Obama has proposed "Quality Affordable Health Care for All Americans," comprehensive health care reform for all that will reduce cost and guarantee choice of doctors and plans. Together with the American Hospital Association (AHA) and the Wisconsin Hospital Association (WHA), we will watch how this proposal unfolds and what our role will be in advocating for our hospitals.

AHA has developed a *Hospitals and Health Reform Policy*. On page one, *Expanding Health Care Coverage*; they state that "Health coverage for all, paid for by all is an essential element of reform. Expanding coverage also is key to cost control, as health care costs are higher when patients do not receive care at the right time or in the right setting. Providing coverage to all will help mitigate the "cost shift" that moves the financial burden of no-coverage from public to private payers..." To read the entire 11-page policy, please go to www.aha.org. There are many obstacles - many pros and cons to reaching an agreement that will benefit the majority.

A great program is planned for Public Policy at Partners of WHA, Inc. 2009 Convention. Our program is entitled "Ingredients for Successful Public Policy Efforts" - what steps legislation goes through before becoming law, best ways to contact your representative, and how to make a difference.
