Bylaws and Honor Points Updated

The hot, lazy, crazy days of summer are upon us; time to get out the grill and make some hot dogs, steaks, and burgers. Now days, I pretty much do that all on the George Foreman grill—not too much for eating outside in the heat. I like my creature comforts more and complete with air conditioning.

During our Spring Tour this year, I went over the by-law changes we will be presenting at our convention in October. I explained who is supposed to do the voting for your hospital—that would be the two delegates that you checked off on the convention registration form. Then, I went through each by-law change to explain exactly what we are trying to change and why we thought the change was needed. Sometimes the change is needed to eliminate a conflict with another by-law or to update what is currently the best and most practical practice. Since I did not get a lot of questions, I will assume you all pretty much understood what I was saying. If you have any questions or concerns, please let me know and we can talk it over. I am always just an email or phone call away.

I also went over the Honor Points so you know what you need to qualify for the Honor Point Award. I hope that helped you understand what was needed to achieve the minimum 40 points to receive this award. Again, if you have any questions, please let me know.

After Spring Tour, I was honored to go to Washington D.C. this year for the AHA/SAL (American Hospital Association/State Auxiliary Leaders) meeting where I met with peers from other states and listened to some really great speakers. Then, we also lobbied “up on the hill” for hospital bill legislation to help our hospitals. It was a wonderful trip and I learned a great deal. One of the speakers I heard during the SAL meeting talked about “Story Tellers.” These are volunteers who sit with older people in their nursing homes, and in some cases hospice, and listen and record and write down their life experiences to hand down to posterity. 2016 Convention Bylaw Changes

Change number 1---ARTICLE 10.1.13 SECTION 4

Currently states:

The Nominating Committee shall select a slate of qualified nominees for the offices of President, President-Elect, Secretary, and Treasurer. This slate shall be published in the Partners of WHA newsletter edition prior to convention.

Change to read:

The Nominating Committee shall select a slate of qualified nominees for the offices of President-Elect, Secretary, and Treasurer. This slate shall be published in the Partners of WHA newsletter edition prior to convention.

Rationale: Eliminate the office of President from this article, 10.1.13 Section 4, to make it coincide with article 10.1.9 section 2 which states:

Terms of office commence January 1, following election at the Partners annual meeting, for two (2) years or until successors are elected. President shall serve one two-year term unless the President-Elect becomes unable to assume the presidential duties, in which case, the President will be eligible to serve a second consecutive two-year term.

President-Elect shall serve one two-year term as President-Elect and then assume the Presidency. Secretary and Treasurer shall serve no more than two consecutive terms in the same office.

Change number 2---ARTICLE 10.1.13 SECTION 3

Per the discussion after passage of bylaw 10.1.13 Section 3 to change the wording slightly from:

Nominations may be made from the floor. Person being nominated must accept the nomination. If not present, the acceptance must be in writing.

To read:

Nominations may be made from the floor. The **qualified** person being nominated **should be present** to accept the nomination. **If they are not there in person then a letter of acceptance from him/her needs to be presented to the nominating committee on or before the day the nominations are presented to the membership.**

Rationale: This will change the word “must” to “should” in case the nominee cannot be present at the appointed time. If not present then there needs to be a written statement that they will accept the nomination and the deadline for when it should be presented to the committee.

Change number 3---ARTICLE 10.1.12 SECTION 1

Currently states:

The Board of Directors shall consist of the President, President-Elect, Secretary, Treasurer, District Chairpersons, and Partners Standing Committee Chairpersons. The immediate Past President shall serve in an ex-officio (non-voting) capacity for a term of two (2) years. The Board of Directors referred to in the Articles of Incorporation on file in this matter will relate to the directors elected pursuant to this paragraph.

Revised to:

The Board of Directors shall consist of the following:

Should any member of the Board of Directors hold more than one (1) voting office they will still be entitled to only one (1) vote per election. (Continued on page 5)

Rationale: List separately each of the standing committee chairs. We are also limiting the past president's vote to the immediate past president, and each district only gets one vote per election—in the event a district should have co-chairs, there is still only one vote.

Change number 4----ARTICLE 10.1.12 SECTION 6

Currently states:

A majority of members of the Board of Directors shall constitute a quorum.

Revised to:

A majority of **voting** members of the Board of Directors shall constitute a quorum.

Rationale: Added the word “voting” to define a quorum as voting members eligible to make decisions on the board of directors.

Consider Applying for a HAVE Award

The 2017 AHA Hospital Awards for Volunteer Excellence (HAVE) will take submissions until September 23, 2016 at 4:30 PM PDT. The program was established by the American Hospital Association to help hospitals and health care systems attract and retain volunteers by recognizing outstanding contributions of organized volunteer programs. In addition, the HAVE Awards acknowledge the value of volunteerism to individuals, organizations, and communities. This is very similar to the WAVE Awards for Wisconsin organizations.

Eligibility requirements include:

- Affiliated with an AHA institutional member hospital or health system.
- Has functioned successfully for at least two years (since September 1, 2014) within a health care organization or a community the organization serves.
- Organizations affiliated with members of the HAVE selection committees are not eligible to apply.
- The organization submitting a nomination may not have received a HAVE Award the previous three years.
- Awards go to specific areas, initiatives or programs, and not volunteer departments or auxiliaries as a whole.

Public Policy Education Report

It has been a turbulent summer on both the national and international scenes. Our presidential primary season has been full of drama and surprises. The outcome of the Brexit vote in Great Britain stunned the world. Shootings, protests, and terrorist attacks challenge political leaders and citizens. Despite these issues, there is optimism and determination to address the problems and find solutions.

The Partners of WHA have encouraging news and something to celebrate. The “Just One More” challenge has shown positive results. Comparing the 2014 and 2015 Public Policy Education state report data, there are increases in Advocacy Day attendance (.9%), legislative contacts (9%), and HEAT membership (9.4%). During Spring Tour, the persuasive power of chocolate was on display. There was a wonderful response to the offer of a little bag of sweet treats as a signing bonus. There are **68** new Partners HEAT members.

While things are quiet on the Wisconsin front since the Wisconsin Legislature is in recess until 2017, the United States Congress is in session. The following pieces of legislation are on the radar:

- **Section 603/HOPD Fix** - Last year, legislation was enacted that created a prohibition on certain hospital outpatient departments (HOPDs) from using an entire Medicare reimbursement system. WHA has been working on a targeted fix for hospitals inappropriately caught up in this prohibition. Recently-introduced legislation (HR 5273) is a step in the right direction.
- **Critical Access Hospitals** - WHA continues to support legislation, including a fix to the 96-hour rule.
- **Graduate Medical Education (GME)** - WHA continues to support and advocate in favor of GME funding, including a targeted approach to address what are known as “legacy” or “micro” caps. These GME caps were inadvertently set decades ago and negatively impact several hospitals in Wisconsin who desperately want to take on more residents.
- **340B Program** - It is important to remain vigilant regarding 340 B. The HRSA will not release its final mega-guidance until late 2016.

Watch for HEAT Alerts specific to these initiatives and contact your representatives to support these important issues that impact Wisconsin hospitals and patients.

Opioid use, abuse, and addiction continue to be in the news nationally and locally. WHA, along with elected officials, are partnering to improve this situation in Wisconsin. One of the ways WHA has been active is offering an educational webinar series. In spring of this year, more than 400 individuals participated in this series. It focused on assisting hospital and health system administration and leaders understand this growing public health issue. Thank you for your advocacy efforts on behalf of Wisconsin communities, hospitals, and patients. Let’s continue to learn about the issues, share our thoughts with our representatives, and exercise our right to vote this fall. You can and do make a difference.

Community Health Education Report

The more we learn about lung disease, the greater the chances of preventing it. The one thing we know about lungs is that they are vital to our life. Just as in the past, education and prevention efforts led to a drop in heart attacks. Experts hope that as more people learn about COPD and lung cancer, fewer will actually get it.

Here are three myths and facts about lung disease.

Myth: Lung disease is rare.

The fact is COPD is the fourth leading cause of death in the U.S. Lung cancer is the leading cause of cancer death among both men and women; about 1 out of 4 cancer deaths are from lung cancer.

Myth: Lung disease only strikes smokers.

The main cause of COPD and lung cancer is smoking and exposure to secondhand smoke. But not everyone is a current or former smoker. Long-term exposure to pollutants and some occupations are riskier for lung health. There are also genetic influences. The number 2 cause of lung cancer is exposure to the odorless radioactive gas we know as radon.

Myth: It's too late to quit smoking.

It's never too late to quit smoking. Your circulation improves and your lungs work better. The risk of lung cancer and COPD start to drop over time. Ten years after you quit, the odds of getting lung cancer will be half of what they are now. At any stage of COPD, quitting smoking will lessen your symptoms and slow COPD progression, and help manage the disease. Your treatment for lung cancer may be more effective and side effects could be milder. If you need surgery, ex-smokers heal better than smokers.

Fact: Exercise is important if you have lung disease.

Exercise helps your lungs work more effectively. It improves the way the heart pumps. It reduces anxiety and stress and improves mood. Exercise also improves cognitive function.

Fact: Early diagnosis helps.

It's crucial to catch COPD and lung cancer early to prevent more damage to the lungs and increase life outcome.

Fact: Everyone should try to prevent infections. Get a flu shot and a pneumonia vaccine.

WAVE Award to be Announced at Convention
