PUBLIC POLICY AND EDUCATION

2020 CENSUS: In October 2019, Governor Evers signed Executive Order #55, for the Creation of a Complete County Committee for the 2020 Census. From the data, the federal government will allocate over \$675 billion dollars in federal funds to states, counties and communities, and the result will determine the number of representatives each state will have in the United States House of Representatives and legislative districts for the State in the assembly.

WHY IS THIS IMPORTANT TO HEALTHCARE?

- 1. The Federal Medicaid Assistance Percentage, FMAP, establishes how Medicaid benefit costs are shared between the federal government and each state. The result is determined by the per capita personal income data collected by the census and the result of both income and population data.
- 2. The Medicare Physician Fee Schedule determines the fee-for-service payments practitioners receive.
- 3. Health Professions Shortage Areas are determined by demographic data received through Census.
- **4.** Medically Underserved Area/populations are those identified that lack access to primary care services.
- **5.** Rural Health Clinic shortages: Governors can designate these areas and provide services through a Rural Health Clinic Certification based on many factors to include the percentage of age 65 and older citizens in particular areas based on census data.

Wisconsin had a respectable return rate of over 85% in the 2010 decennial census. Hopefully, we will meet or exceed that return in this critically important period.

The United States Census 2020 is of vital importance to healthcare. Since the U. S. census is only taken every ten years, it is important to view the changes in the status from the past ten years and to predict on the next ten years. Census data is used to distribute more than \$675 billion in federal funds to states. The largest impact is the federal Medicaid program in which the census data is used to allocate matching funds to states. In 2015, over \$300 billion of matching funds was used for Medicaid to states using census data. Undercounting people who live in Wisconsin costs the state healthcare revenue and impacts political representation as U. S. congressional seats are allotted based on state population.

An area affected by the census is the Medicare Physician Fee Schedule. The fee schedule is based on codes that represent the cost of resources required to provide partial procedures or services. Part of the census data provides one-year estimates of economic characteristics and wages. This is a simplified explanation of how the fee schedule is determined.

The U. S. Census Bureau data helps to determine Heath Professions Shortage Areas. It also identifies Medical Underserved Areas and Populations. This information indicates geographic areas and populations which lack primary care. Census data shows provider per 1,000 population ratios, percent of population at 100% of the federal poverty level, percent of population 65 and over, and infant mortality rate. Rural Health Clinics indicate where the percent of the population is higher than the state average.

In Wisconsin, 7% of the current population (394,796) lives in hard to count neighborhoods. Almost a quarter did not respond in 2010, and after much follow up, 7% did not respond. The Census Bureau is urging most households to respond online via internet. The Waukesha area, and most northern counties across the state have no internet and dial up only.

To be effective and to make an impact on the entire Wisconsin population, all persons must be counted.

WHO ARE WE?

PARTNERS OF WISCONSIN HOSPITAL ASSOCIATION (WHA) WHO ARE WE? By Jan Molaska, President of Partners of WHA

Many of you are probably under the assumption that your auxiliary or volunteer group is an entity in and of itself. Each local organization might do its own thing but there is a much larger picture. Many local organizations belong to districts and the districts make up Partners of WHA - the state-wide organization that represents healthcare volunteers from all over the state of Wisconsin.

I recently received this comment from a new member of a local board - it seems that the lack of knowledge of the "Partners" is itself a void. As I said, until I became involved in the Volunteer Partners Board, I do not believe that I had heard what "Partners" was or even the existence of it. The void is huge.

Partners of WHA (Wisconsin Hospital Association) Inc. is a non-profit, state wide volunteer service organization representing over 8500 hospital volunteers, of which the Wisconsin Hospital Association is a strong supporter.

The President of the Board moves into the presidency following two years as president-elect. A president-elect, secretary and treasurer are elected biennially by the voting delegates at the State convention.

(*The volunteers of HSHS Sacred Heart Hospital are members of this organization and a part of the West Central District of the Partners of WHA.)

The statewide Partners of WHA organization is divided into 7 districts. The districts and number of local hospitals they represent include: Lakes (9 hospitals), North Central (10 hospitals), Northwestern (6 hospitals), Southeastern (7 hospitals), Southern (7 hospitals), West Central (6 hospitals), and Western (9 hospitals). Local organizations operate by the policies that their members establish.

In 2019 alone, 56 member organizations, representing 8500 volunteers donated 894,070 hours to their respective hospitals and communities. Money donated back to hospitals totaled \$1,706,170.70 in 2019 and 339 scholarships amounting to \$371,125.00 were presented.

Advocacy is a critical element of the work of the Partners. Partners' advocacy is grounded in the belief that people matter and their collective voices are powerful in shaping the future of healthcare. A tremendous number of Partners members show up yearly at WHA's Advocacy Day and visit with their State legislators. WHA's Hospitals Education and Advocacy team (HEAT) helps members communicate with local, state and federal legislators on legislative issues that impact our hospitals, our clinics, and the well-being of all people.
