On January 1, 2012, Partners of WHA began a new fiscal year. Looking back on 2011, we accomplished our financial goal of maintaining a balanced budget. We now look forward to maintaining the balanced budget for 2012 as approved by the membership at the convention last October. The Partners of the Wisconsin Hospital Association accomplishes our financial goal through the dues paid by our members, the profits from our annual convention, and the generous donation made by the Wisconsin Hospital Association.

The Partners annual expenses include the cost of running our organization in accordance with the Partners of WHA, Inc. bylaws and policies and procedures. They also include the cost of maintaining our Leadership Handbook, our Resource Center and our website, and the cost involved with this newsletter.

According to the Partners of WHA, Inc. bylaws, each member organization is assessed one dollar annually for each member in their organization. The number of members in an organization is taken from the local president's annual report filed in January. Of the amount collected, 20 cents per member is returned to that organization's district for that district's expenses. Districts do not charge dues.

A dues notice will be sent out to each local president in April. Dues must be paid to the Partners of WHA, Inc. treasurer by June 30, 2012 to be eligible to receive "Honor Points" for 2011.

Call for Candidate Recommendations



WHA President's Report

100 New Physicians a Year: An Imperative for Wisconsin

WHA released a report on November 29 calling for concerted and collaborative action to address a looming physician workforce shortage. The shortage will be especially acute for primary care doctors who are expected to lead delivery system transformation through widespread adoption of medical homes....a strategy necessary to achieve improved care coordination and management as the field moves away from fee-for-service based health care delivery and payment.

The report, already vetted and approved by WHA's Board and shared with stakeholders, suggests that there is no "magic bullet" that will meet the daunting challenge of addressing a conservatively estimated shortfall of 2,000 physicians in 2030. But specific

issue areas that will address the challenge are identified, and specific solutions are discussed. The issue themes include:

- The need to expand Wisconsin Graduate Medical Education Programs
- The need to increase the number of Wisconsin medical school graduates
- The need to focus on and address tuition and tuition-related debt
- The need to coordinate and advance changes in care delivery
- The need for an infrastructure that will advance identified strategies that address the challenge.

The report is a seminal document that for the first time in recent history documents an emerging crisis and presents a road map for necessary address.

WHA's 2011 HEAT Report

Closing Out 2011, Looking Forward to 2012

2011 was quite a year politically in Wisconsin, but all the tumult did not deter HEAT advocates from positively engaging in the legislative process at the state and federal levels. The Wisconsin Hospital Association thanks you for your efforts on behalf of your hospital and hospitals statewide. To close out 2011, we wanted to give you a glimpse at some of our major grassroots efforts/initiatives and how your action made a difference.

• Federal Deficit Legislative & Grassroots Campaign – 2011 was wrought with policy proposals aimed at cutting hospital Medicare and Medicaid reimbursements in order to come up with trillions in federal deficit reduction. To combat these drastic cuts, WHA launched one of its most aggressive, sustained grassroots campaigns to date. All total, this campaign: generated over 2,100 emails to Members of Congress from two HEAT action alerts; placed dozens of letters/op-eds in papers across the state; spearheaded a "dear colleague" letter (led by Rep. Ron Kind) which garnered support from 68 other Members of Congress; led several Capitol Hill day trips with hospital representatives to Washington, DC; and coordinated high-level in-district meetings between hospital CEOs and key Members of Congress. While hospital advocates successfully pushed these cuts back in 2011, we will face these proposals again in 2012 and need

Annual Advocacy Day – this event has become one of the largest events in the State Capitol in Wisconsin. Due to
hospitals' commitment, Advocacy Day topped out at 757 registrations in 2011, WHA's biggest ever. A full 450 of those
individuals then went on to meet with their legislators in the State Capitol that afternoon. 2012 Advocacy Day is
April 24 and registration is now open at: http://www.wha.org/advocacy-day.aspx.

In 2011, WHA also led several Capitol Hill days in Washington, DC where dozens of hospital representatives were able to speak personally with Wisconsin Members of Congress against

cuts to Medicare and Medicaid.

- Hospitals Education & Advocacy Team (HEAT) Membership close to 700 new members joined the HEAT program in 2011, the largest surge in membership since the HEAT program began in 2005. HEAT membership is now at an all-time high of over 2,100. Recruit other volunteers to join HEAT!
- Hospitals Host Legislators hospitals across the state hosted their legislators for meetings, tours, and "shadow days" throughout 2011. This year, 13 shadow days were held and at least 50 other face-to-face visits occurred.
- Legislative Webinars in an effort to educate and prepare hospital CEOs, HEAT members, and others on important issues, WHA's 2011 legislative webinar schedule included: "Legislative Process 101," "State Budget," and "Grassroots 101." Some 300 individuals attended these three webinars.

Your community hospital needs you to speak up with legislators. By working with WHA through our HEAT grassroots program and attending Advocacy Day for example, you are making an impact. Let's continue to do so in 2012!

Did you set your goals for 2012? Did they include an exercise regime, proper nutrition, weight loss, and motivation to help yourself and others?

Our Community
Health Education focus is
on DIABETES again this

year. Diabetes is everybody's problem. How bad is the epidemic? The number of people with type 2 diabetes has tripled in the past 20 years and the pace is accelerating.

What causes diabetes? Mostly your refrigerator and your couch!! Lack of movement contributes to weight gain. It also shuts down a key enzyme in muscle called lipoprotein lipase, which plays a role in blood-sugar regulation. Get up during a TV commercial, or put down the book and walk or dance around the house. Put simply, nothing influences whether you get type 2 diabetes as much as your weight. And if you have diabetes, nothing influences your taming of it as much as losing those extra pounds.

Here are some easy moves to do when you are sitting in your favorite chair or recliner:

Leg lifts: keep one foot on the ground; lift the other leg off the ground a few inches. Raise and lower the leg 10 to 20 times, then switch legs and repeat on the other side.

Shoulder shrugs: this exercise can help relieve tension due to our stressful living. Slowly lift your shoulders toward your ears, hold for a few seconds, and slowly lower them. Repeat 10 times.

These simple exercises that stretch and strengthen your muscles not only burn calories, they help you feel refreshed and limber throughout the day.

Around the State

Osceola Medical Center, Osceola:

Partners of Osceola Medical Center (OMC) and the OMC Rehab Department teamed up to create a unique program called "The Silver Slipper Exchange" in October 2011. Seniors who had a history of or the potential for dangerous falls were invited to take part in the program, which consisted of them bringing in an old pair of slippers in exchange for a pair of new non-slip slippers. Approximately 70 seniors took part in the program. OMC doctors, nurses, Rehab personnel, and Partners volunteers manned the event. In addition to the slippers, seniors were treated to some additional foot care services, refreshments, and door prizes. Partners provided funding for this program and individual Partners provided the door prizes.

Aurora Health Care Volunteers, Milwaukee:

Dana Molumby retired as the president of the Gift Shop at the end of 2011. She has been the president for more than 20 years and had been a volunteer since October 1976. Under her leadership, more than one million dollars has been donated to the volunteers to be used for scholarships, special projects, and equipment that the hospital was unable to fund in their budgets. Dana has given 30,558 volunteer hours to the hospital through December 2011, and has the record of having volunteered the most hours of any of the hundreds of volunteers recorded. A retirement party was held January 19, 2012.

Aurora Lakeland Medical Center Volunteers, Elkhorn:

Christmas caroling was provided to patients and employees in December by volunteers, some employees, and several Barbershoppers for one day.

Volunteers in Partnership with River Falls Area Hospital, River Falls:

"Big bucks" were made by this volunteer organization for the Harvest Barn Dance with about \$52,000 being raised. Another \$2,517.99 was raised for their Fall Salad Bar Luncheon. That's giving a lot back to the hospital!

St. Mary's Superior Auxilians, Superior:

This organization had their first "Big Baked Bar Bake Sale" where oversized, tempting bars were precut and placed for sale. Sales went fast and a great profit was made.
